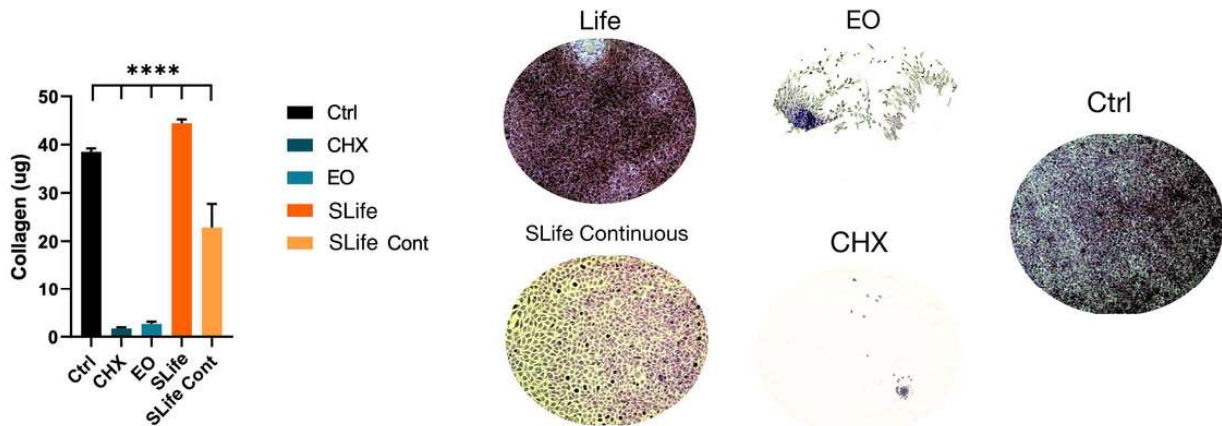

CONCLUSION

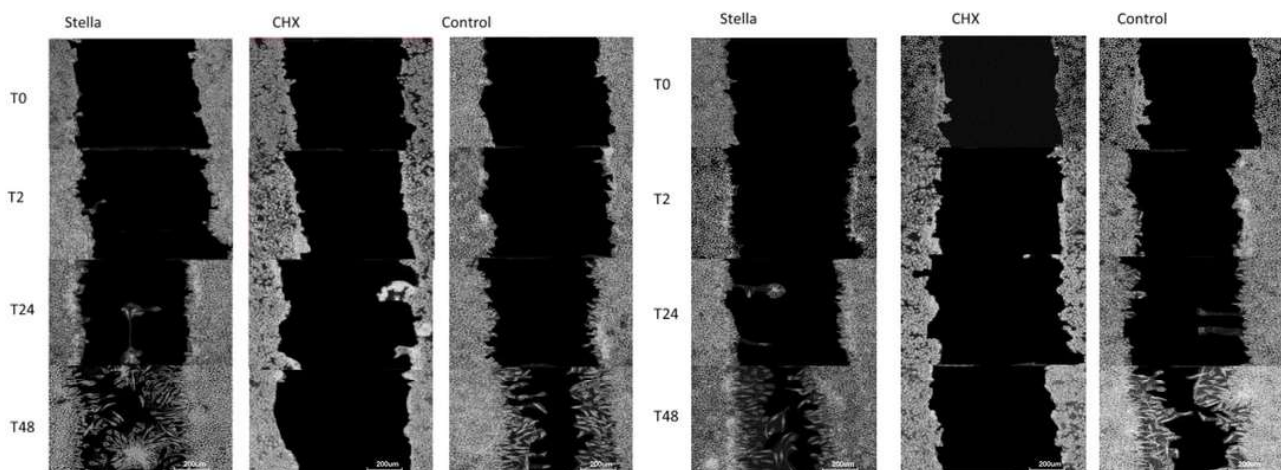
Results of the present study show that an herbal extract compound-based oral rinse did not demonstrate toxicity to fibroblasts and oral stem cells when applied for clinically relevant exposure times. Contrary to currently used oral antiseptic rinses that impaired wound healing as an adverse event, it supported wound healing comparable to control tissue culture conditions. Thus, the potential to improve oral wound healing warrants further investigation in ex vivo models including oral bacteria and in well controlled human studies to assess clinical effects.

CONCLUSION



The findings from the present study report that the use of VEGA oral rinse was far superior to CHX in terms of cellular biocompatibility, ability to induce cell migration, proliferation, gene expression, and collagen synthesis. We further demonstrated the negative impact of CHX on the cellular inflammatory response of human gingival fibroblasts that may further lead to reported patient pain. Last, we provide support from the basic laboratory that further validates the previous clinical studies supporting the use of the VEGA oral rinse on its superior biocompatibility when compared to CHX.

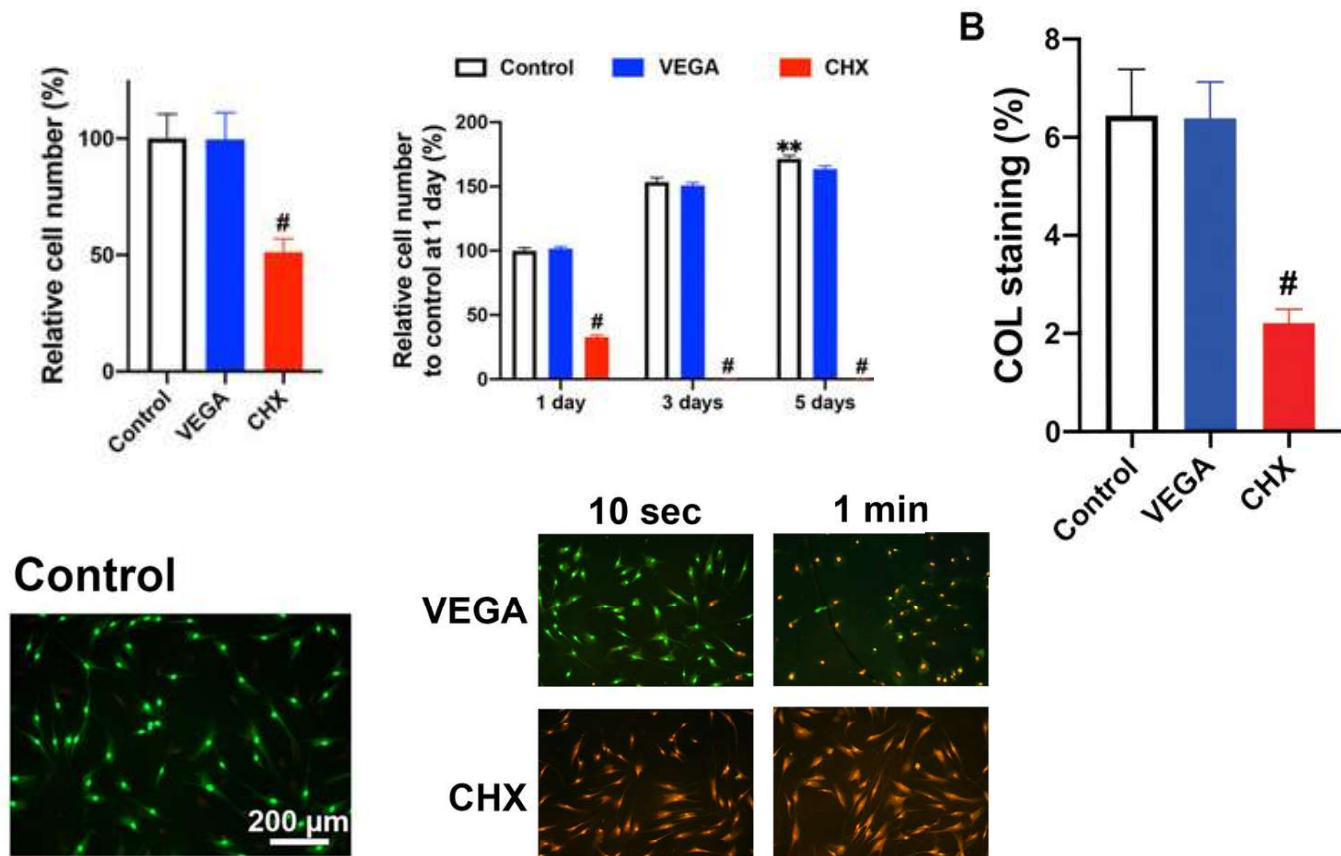


Figure 1. Cell viability of human gingival fibroblasts (HGF-1 cells).

CONCLUSION



CHX and PVD demonstrate superior antibacterial properties, but significantly reduce HGF proliferation. AO is bacteriostatic at lower dilutions but is highly toxic to HGFs. EGA was bacteriostatic and demonstrated no detrimental effects on HGF's.

BACKGROUND:

PURPOSE:

The authors examined whether a novel alternative treatment regimen that is opioid-free administered preemptively 3 days prior to block bone graft surgery of the mandible has a preemptive analgesic effect on the intensity of pain at the graft harvest site during the 72-hour postoperative period.

CONCLUSION:

The results of the study illustrate that postoperative pain intensity was lower in the group of patients with the opioid-free regimen when used preemptively compared to the group of patients that did not receive the opioid-free regimen. Further, use of this novel treatment alternative in managing postoperative pain resulted in less consumption of opioid analgesic medication and increased the time interval to first use of an opioid analgesic. The results of this pilot study support the need for novel alternative and complementary analgesic strategies.

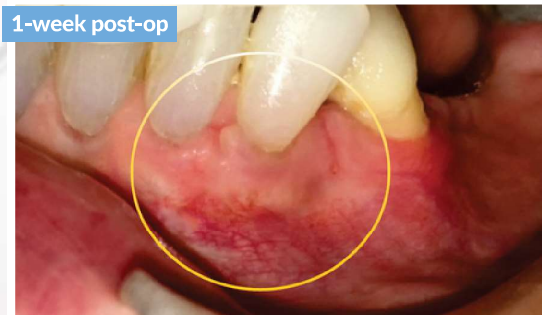
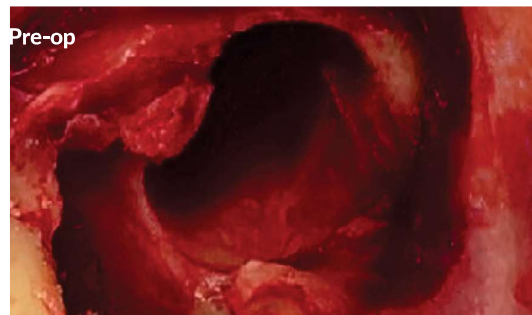

SURGICAL APPLICATIONS

BONE GRAFT PROCEDURES

On-lay Bone Graft • Sinus Lift, GBR

Recovery Kit. Patients start 3 days before and continue for 5-7 days post-operatively. After 7 days, continue to use Rinse 2x/day.

REMOVAL OF IMPACTED DENTITION

Recovery Kit. Refer to how to use Recovery Kit.

IMPLANTS

Recovery Kit or Gel & Rinse. DentaMedica

4-8 weeks prior to surgery start DentaMedica.

Rinse, For routine procedures, not involving BG, CTG.

Post-op: Patient instructed to rinse for 1-2 minutes and expectorate; immediately apply Gel at the surgical site and vestibule area. Repeat above steps 4x/ day or more (per clinician's discretion) After 5 days, patients are instructed to soak a Q-tip in the Rinse and swab clockwise around the healing abutment for 1 minute, 2-3x/day. Continue for the next 2-3 months during integration, When patients are seen for final check prior to the restorative stage, they are instructed to apply Rinse with a Q-tip at the cervicogingival junction of the future restoration 2x/day as part of routine hygiene.

PERI-IMPLANTITIS

Recovery Kit or Gel & Rinse.

1. For soft tissue inflammation only without bone loss: Remove the cause (debris, cement, etc.). Use 24G angiocath to introduce into the pocket and rinse it out
2. with VEGA Oral Rinse (up to 20 ml). Home care: Apply the Rinse with a Q-tip at the cervicogingival junction for about 1-2 min with gentle pressure massaging the gum, then immediately apply Gel in the same area. Refrain from
3. No eating and drinking for 20 minutes after application. Repeat 3-4x/day for 1 month, then re-evaluate.
4. If bone loss is present: detoxification, implantoplasty, GBR per individual protocol. Home care: Apply the Rinse with a Q-tip at the cervicogingival junction for about 1-2 min with gentle pressure massaging the gum, then immediately apply Gel in the same area. Refrain from eating and drinking for 20 minutes after application.

ROUTINE EXODONTIA

Gel and Rinse Post-op. Patients are instructed to rinse 1-2 minutes and expectorate; immediately apply Gel at the surgical site. Repeat above steps 4x/day.

EXPOSE AND BOND, ORTHO ANCHORAGE PLACEMENT, APICOECTOMY

Recovery Kit. See How to Use Recovery Kit. Alternative, Post-op: Patient instructed to rinse for 1-2 minutes and expectorate, immediately apply Gel at the cervicogingival junction. For best results start 3 days pre-op. Repeat above steps 3-4 x/day for 7 days after the procedure.

SCRIP

Gel & Rinse or Recovery Kit. Probiotics Kit.

Post-op: Patient instructed to rinse for 1-2 minutes and expectorate, immediately apply Gel to treated area. Repeat the above steps 4x/day. Home care: Apply the Rinse with a Q-tip at the cervicogingival junction for about 1-2 min with gentle pressure massaging the gum, then immediately apply Gel in the same area. Refrain from eating and drinking for 20 min after application. Repeat 3-4x/day for 1 month, then re-evaluate. Note: To reduce bleeding during the SCRIP, start patients on the regimen 3 days pre-op. See How to use Recovery Kit.

CTG, PERIO & LASER SURGERY, FRENECTOMY, OSSEOUS SURGERY

Recovery Kit. If autogenous tissue is used from the palate, ask patient to apply with Q-tip StellaLife Gel at the harvest site as well as at the recipient site and vestibule area around the surgical site.

1. ABx and intra-op PRP/PRGF/PRF recommendations per clinician's protocol.
2. After initial use of recovery kit regimen, patients should continue to use rinse 2x/day until complete healing is observed.

NON-SURGICAL APPLICATIONS

Dry Mouth: Rinse for 1-2 minutes to relieve dry mouth symptoms. Repeat 3-4 times/day.

Bad Breath / Halitosis: Rinse for 1-2 minutes to eliminate odor-causing bacteria. Use Oral Lozenge in Probiotics Kit at least 1 hr after Rinse to establish healthy oral microbiome. Repeat 3-4 times/day. Probiotics kit is a very beneficial adjunct to the Rinse and should be used together.

Aphthous Ulcers: apply Gel to the ulcer with a Q-tip 5-7x/day. Symptoms/lesions should resolve within 2-3 days. Rinse is a very beneficial adjunct to the Gel and should be used together. Rinse 1-2 minutes, then immediately apply Gel.

Dry Socket: Gel and Rinse. Apply Gel in the office first, allow to take effect for 10 minutes, then check with the patient. They will experience immediate relief. For home care, use Rinse and Gel 4x/day. Rinse 1-2 minutes, then immediately apply Gel.

Orthodontic treatment & Invisalign: Apply Gel into the Invisalign tray for dental pain or apply directly to the gum 3x/day or as needed. Use Rinse for routine hygiene care twice per day. Rinse 1-2 minutes, then immediately apply Gel.
